Dear Vice President Harris & President Trump:

The undersigned organizations have a long and powerful history of advocating for consumers across the economy, including on behalf of some of our nation's most vulnerable populations. We write to you in strong support of Federal Trade Commission Chair Lina Khan, and, should you be elected President, we urge you to reject the demands to fire her from her position at the FTC. Chair Khan has helped revitalize the FTC with a renewed focus on restoring trust and accountability to the marketplace and securing economic freedom for people and small businesses.

Chair Khan has made it her mission to hear from and respond to the challenges that face Americans across the economy. During Chair Khan's tenure, the FTC has renewed its open commission meetings, where members of the public can register to talk directly to the Commissioners about their experiences. She has taken bold steps to strengthen data privacy, particularly for children and teenagers, by expressly moving away from the harmful "notice and choice" regime, pushing for stronger consumer protection rules, and bringing groundbreaking enforcement actions. Chair Khan has been a champion in the fight against harmful and pervasive junk fees, proposing an all-in pricing rule that

allows companies to honestly compete on price rather than false pretenses,³ and a transparency rule for car buyers that will save them at least \$3.4 billion and 72 million hours as they shop for a new car.⁴ Chair Khan has pursued rulemakings and policy initiatives aimed to ensure that it is as easy to cancel a subscription as it is to enroll,⁵ equip the FTC to return money to the victims of pervasive frauds and scams,⁶ and protect small business franchise owners from exploitative practices.⁷

Chair Khan has been a powerful advocate for communities that are frequently targeted by scammers. She has enhanced the FTC's efforts to protect older Americans from frauds and scams,⁸ penalized companies for targeting servicemembers, veterans and their families with fraudulent job offers and fake student loan assistance, and sought justice for the victims of racial discrimination.⁹

During her time at the FTC, Chair Khan has secured bipartisan support on many key issues, including cracking down on false "made in USA" claims, investigating surveillance pricing tactics, blocking anticompetitive mergers, and protecting consumers' right to repair their own devices. This work underscores the point that consumer protection is not – and should not be – a political exercise.

We urge you to reject the demands to fire Chair Khan should you become President and to express your full support for her work at the FTC. Consumers stand to lose many
