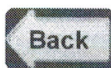
DO NOT include any personally identifying information from this point forward.

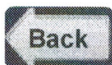

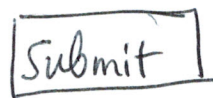

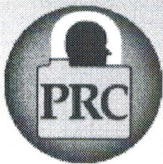
